IDENTIFY / ISOLATE / INFORM Use for any suspected Highly Infectious Disease patient (Ebola, MERS, SARs, Pandemic Flu, novel diseases)

Reception or 1st **Facility Contact**

- drop-down box.

Hand the patient a mask to wear and ask the patient to wait on the side away from others. Explain to the patient that a nurse has been called to escort them to a room.

Nurse or designated ID responder in clinic/ED

Don N95 respirator and escort patient to a designated Airborne Infection Isolation Room (AIIR). Explain to patient that you will be <u>donning PPE</u> and will return to complete the intake.

If an infectious disease is suspected, page Infectious Disease (ID)-MD-on-call for assessment. Follow orders of Infectious Disease MD. Notify Infection Prevention, area supervisor, and physician on site (or active designated response team for the facility). DO NOT move patient out of isolation room until given go from the Emergency Operations Center (EOC). Identify on-scene incident commander and/or Charge RN.



EOC & Site Coordinator

- EOC
- (Ebola, MERS, SARs, Pandemic Flu, novel diseases)
- **Assign Incident Command Roles** Include Infection Prevention and ID MD as subject matter experts



Notify as needed: Department of Health (DOH), Centers for Disease Control and Prevention (CDC), Healthcare Association of Hawaii (HAH), National Kaiser Healthcare Continuity Management.

ACTIVATE / COORDINATE / TRANSPORT

Decision to transport/admit made by ID MD by notifying the Administrator on Call (AOC). AOC to activate Emergency Operations Center (EOC) for Aerosol Transmissible Disease.

EOC to arrange AMR transport or MOA admission based on guidance from ID MD, Hawaii Department of Health (DOH), and the Centers for Disease Control and Prevention (CDC). EOC & Site Coordinator in constant contact to assure readiness on sending and receiving end before patient is moved.

ACTIVATE / COORDINATE

Emergency Operations Center activated for Aerosol Transmissible Disease (ATD)

EOC to follow Incident Response Guide (Ebola, Pandemic Flu, Surge, ATD). Modify as needed. Follow Airborne/Droplet/Contact and other Isolation Precautions as appropriate.
